International applicants requesting immigration documents from IUP must submit a financial statement that shows their best estimate of funding sources to support their studies and cost of living. Once a student is admitted, the Office of International Education will work with students to confirm their funding sources (scholarships, loans, assistantships) and request more documentation prior to issuing an I-20. IUP does not offer full scholarships. When applying for an F-1 visa at a US consulate, students will need to share very detailed bank statements, tax documents or additional proof of finances.

This amount must be shown regardless of the length of time your dependent(s) will stay in the U.S. F-2 visa holders are not authorized to work in the U.S.
