

## California State University, Bakersfield Affidavit of Financial Support for Undergraduate Programs

Applicants holding or requiring F-1 Student immigration status are required to provide appropriate documentation of financial support before a form i-20 can be issued.

Since financial aid or employment is not available to nonresident alien students, you must have sufficient funds to sustain yourself. If the student will use their own personal funds as the source of financial support, the student MUST PROVIDE THEIR BANK STATEMENT showing the availability of at least \$34,000 in liquid assets. Bank statements and financial affidavits <u>can be no older than 3 months</u>.

If the Student will be supported by a private sponsor (family member, friend, private institution...etc.) the sponsor must sign the Statement of Financial Obligation below. In addition, sponsors MUST PROVIDE THEIR OFFICIAL BANK STATEMENT showing the availability of at least \$34,000 in liquid assets. Bank statements and financial <u>affidavits can be no older than 3 months</u>.

If the student will be sponsored by a public agency (embassy, home government, public institution, religious organization...etc.) the agency must provide official certification that the appropriate costs will be covered. Sponsorship statements can be no older than 6 months.
