In order to be issued a Form I-20 from Saint Leo University, students must demonstrate the financial ability to pay for at least one year of academic and living expenses. This includes direct costs (tuition & fees, room & board) as well as indirect costs (books & insurance) that are associated with a Saint Leo University education. The cost of attendance is estimated based on fulltime enrollment status for a 9-month period. Undergraduate full-time enrollment is between 12-18 credit hours per semester, while the minimum graduate full-time enrollment is 6 credits per semester. The cost of attendance is subject to change each year.

All supporting financial documentation must be in English or accompanied by a notarized English translation showing available liquid funds. The financial documents cannot be older than six months at the time of submission to Saint Leo University in order to be considered valid. These financial documents include, but are not limited to, bank statements and letters, government or organizational scholarships. These items can be sent electronically, through postal mail or faxed.

Once your documents have been received, Saint Leo University will issue the Form I-20. You will receive an email with shipping and payment information to receive your Form I-20.
