



## MBA OFFER LETTER

Dear Jatin Kamboj,

Hellenic American University is pleased to offer you a place in the MBA program and a scholarship of \$28,000 for the Hellenic American University making the total program price for your entire MBA \$14,000.

To confirm that you accept this offer please read this letter, sign it and then return it to the HAU Admissions Office. You are responsible for keeping a copy of this Offer Letter and receipts of any payments of tuition.

By accepting this Offer you understand that:

- You need to notify Nashua Student Services of your arrival in the United States by the specified Program Start Date which is provided to you in the I-20 and Letter of Acceptance. You are required to arrive on the Nashua campus for your scheduled orientation which is outlined in your Welcome Letter upon visa approval.
- By taking advantage of the scholarship tuition, you are required to pay an enrollment deposit of \$7,900 within 20 days of receiving your visa or upon arrival in Nashua, NH USA campus. The deposit will be used to pay for tuition, fees, and medical insurance after you have enrolled. **The arrival date cannot be after the Program Start Date specified in your I-20 form.**
- The enrollment deposit includes a mandatory administrative fee of \$2,500. The Administrative Fee Policy, which is outlined in the email where you received your I-20 Packet states that this fee is a portion of your tuition and fees balance with Hellenic American University. **It is a mandatory fee.** Failure to pay the administrative fee is a violation of University policy.
- If you choose to take advantage of the scholarship, then no refunds are pertinent. The remaining tuition balance is due as followings: \$3,500 no later than 30 days before the start of your second semester and the remaining \$3,500 no later than 30 days before the start of your third semester. A notification on the payment of this amount is sent to you 30 days before it is due.
- The scholarship represents the total price for the entire MBA program and there are no per course/subject prices.
- If a student is unable to arrive to the US for any reasons the student may complete a Refund Request Form and agrees to the terms in their I-20 Packet.



- Note that failure to meet the financial obligations stated in this letter or failure to report to the DSO, to enroll in courses or keep the minimum required course load may end in termination of your VISA.
