

AFFIDAVIT OF FINANCIAL SUPPORT

All F-1 students are required to provide documentation of financial support before a Form I-20 can be issued.

If the student will use his/her own personal funds as the source of financial support, the student MUST PROVIDE A BANK STATEMENT showing the availability of at least \$35,000 (undergraduate) or \$34,000 (graduate) in liquid assets. Bank statements and financial affidavits should be dated no earlier than June 1st for spring applications or October 1st for fall applications.

If the student will be supported by a private sponsor (family member, friend, or private institution), the sponsor must sign the Statement of Financial Obligation below. In addition, sponsors **MUST PROVIDE A BANK STATEMENT** showing the availability of at least \$35,000 (undergraduate) or \$34,000 (graduate) in liquid assets.

If the student will be sponsored by a public agency (embassy, home government, public institution, religious organization, etc.), the agency must provide written verification that the costs will be covered. Sponsorship statements should reflect the semester and year of the application.
