I understand that I also have to pay non refundable fees and embassy fee of INR 1,00,000 (excluding GST) and US\$ 140 for Student visa to US Embassy via their national Capital ATM linked credit card.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation. I completely understand that in case embassy stops providing the embassy dates or is closed due to any unavoidable circumstances ESM cannot be held liable for that and therefore NO REFUND cannot be demanded from the company.
