I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD \$ 185 for Student visa to US Embassy via their channel partner AXIS Bank/credit card. I completely understand that if due to any discrepancy in my documents or due to any changes made in documents after my application, if embassy needs me to pay the embassy fee again I will pay it on my own and ESM has no concerns with it.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation.
