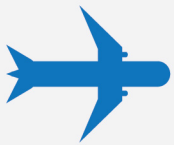

## REFUND POLICY

Refund procedure at QUEEN'S EDUCATION GROUP (QEG) (hereinafter Agreement ) prescribes the procedure by which the tuition fees paid by the students shall be refunded by QEG. QEG is a global recruitment partner of IAU. All the students must comply with the below policies.

### **QEG will NOT refund the tuition fees paid by the student if:**

1. The student pays the tuition fee after getting an F-1 visa with IAU's Form I-20 & enters into the USA.
2. The student fails to check in with IAU within 10 days after entering the US, fails to register for classes by deadline dates, fails to commence studies on the official start dates, or fails to comply with any USCIS regulations or IAU policies resulting in expulsion or withdrawal from IAU.

### **QEG will refund the tuition fees paid by the student if:**

1. IAU cancels the implementation of the education program due to an insufficient number of students. In this case, the student is entitled to have the tuition fees paid in advance reimbursed in their entirety.
2. The implementation of the education program is temporarily suspended or withdrawn completely without offering the student an alternative of continuing education at another program or at another accredited educational institution that has an agreement with IAU. In this case the student is entitled to receive the refund of the tuition fees that have been paid for the non-delivered classes. The amount of the reimbursement is calculated by QEG.
3. The student withdraws the registration/enrollment from the study before the student enters the USA with a Form I-20 from IAU and F-1 visa for IAU. If the student comes to the USA with a Form I-20 from IAU and F-1 visa for IAU, then students cannot request a refund under any circumstances.

The student petitions in writing for a refund for reasons not stipulated in this Agreement. In this case, QEG will assess the explanation as determined by its Board of Directors.

QEG will refund the tuition fees paid by the student through bank transfer directly to the bank account specified in the registration form submitted by the student. Student to provide complete and precise information about the account holder and the corresponding financial institution.
