The case of the petitioners is that they are major and have contracted marriage on 23.2.2009. The marriage certificate and the photographs evidencing marriage have been placed on the file. It is alleged that they apprehend danger from respondents No.7 to 9. To seek redressal of their grievance, they have submitted representation dated 24.2.2009 (Annexure P-5) to the S.S.P., Sangrur.

Notice of motion to Advocate General, Punjab.

On the asking of the Court, Sh. K.S. Pannu, Assistant Advocate General, Punjab, who is present in Court, accepts notice.

So, the directions are given to S.S.P., Sangrur, to decide the representation of the petitioners (Annexure P-5) within one month from today, keeping in view the threat perception to the petitioners.
