Important Note

1. A candidate shall be deemed to have passed if he/she secures at least 33% marks separately in theory and practical (wherever applicable) examination in each subject, following which marks obtained in CCE in each subject will be added. However, it is not mandatory to pass in CCE, At least 33% marks in aggregate in each subject shall be required to pass the examination.
2. A correction in the result can be made under 'General Regulations regarding Board Examination', Chapter II "Correction of Result." If the Board is informed of a mistake incurred at Board's level in the issued certificate within two years, then the mistake shall be rectified without charging any fee. If any mistake is notified after stipulated period, prescribed fee for certificate correction in certificate shall be charged.
3. In case of Tampering in the certificate, strict punishment shall be awarded under General Regulations of Board Examination in Chapter I, under which result of the concerned may be cancelled and he may be debarred from taking the examination up - to a period of 5 years.
