

- (v) You shall have to deposit a sum of amount equivalent to two months' salary as security. It shall be deducted from your salary in twenty four monthly installments. If at any time after fulfilling the stipulations made in paras (ii) and (iii) above, you decide to leave the service, this amount of security shall be refundable to you, after adjusting the amount, if any, due from you.
- (vi) Besides the stipulations made in paras (ii) and (iii) above, your service shall be governed by the provisions of the Rules, Regulations and Guidelines of the Organization as framed and modified by the management from time to time.
- (vii) You shall be whole time employee of the Organization and shall not engage in any other employment, businesses, profession or trade, whether directly or indirectly. You are expected to devote your energy and efforts wholeheartedly towards the affairs of this organization and work honestly and diligently.
- (viii) You are liable to be transferred to any other institution managed or run by this Organization anywhere in India.
- (ix) You shall submit your Medical Fitness Certificate from a qualified MBBS Doctor along with original test reports on Hb, ESR, Chest X-Ray and Pregnancy Test (for married female candidates only) within one month of your joining duty.

On the successful completion of your education/training in the Akal Institute of Rural Women Empowerment, Baru Sahib, you are hereby appointed as "Music Teacher" in the Akal Academy Baru sahib with effect from 17th August, 2015 on the following terms and conditions:-

- (i) You shall get a Gross Salary of Rs. 10,900/- (Ten Thousand nine Hundred) only per month.
- (ii) In consideration of the fact that you were provided free education/training in the Akal Institute of Rural Women Empowerment of the Kalgidhar Trust/Society at Baru Sahib, including free board, lodging, books and stationery etc., you had undertaken to serve this Organization for a minimum period of five years. Accordingly, you are hereby enjoined the obligation of serving this Organization for a minimum period of five years, failing which you shall be liable to reimburse to this Organization the cost of your education/training for the period your service would be short of five years, proportionately. The cost of your education/training involved a sum of Rs. 8000/- P.M. for the period you received education/training plus interest at the rate of 10% to be compounded annually, w.e.f. the date of your joining service till the date of final payment of the amount.
- (iii) The period of five years stipulated in para (ii) above would mean a service with impeccable conduct and excellent performance during your stay in this Organization. If at any stage you are found wanting in these areas and you create circumstances which may lead to your termination of service before completing the minimum period of five years, you shall remain liable to pay for the period your service remains short of five years, as indicated in para (ii) above.
- (iv) In case you would wish to be relieved after successful completion of the mandatory service of five years, you shall have to give three months' notice in writing or pay three months' salary in lieu thereof. Similarly, if the management would at any time decide to relieve you, it shall also serve you with three months notice or pay three months salary in thereof.


