

The above fee is only valid to process the admission in three universities/college and one time visa i20 after admission is done and ESM is not liable to provide all the three I20's to the student. I understand the entire fees paid to ESM INDIA for any purpose involved in the visa process are completely NON- REFUNDABLE and non-transferable. After successful visa approval, I also agreed to pay a consultation fee of Rs. 50,000/- (excluding GST) before collecting my visa copy.

I solemnly declare that I agree to pay any application fee, i20 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for the same. I understand that I have requested my Advisor to assist me for my admission in US University/College in which I am eligible for admission in desired program. I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.

I understand that I also have to pay a non refundable Sevis and embassy fee, which is USD \$350 and USD \$ 160 for Student visa to US Embassy via their channel partner AXIS Bank/credit card.




