I solemnly declare that I agree to pay any application fee, 20 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for same. I understand that I have requested my Advisor to assist me for my admission in UN University/College in which I am eligible for admission in desired program. I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.

I understand that I also have to pay non-refundable travel and embassy fee, which is USD \$350 and USD \$ 185 for Student visa to US Embassy via their charter partner, AXIS Bank/credit card.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer to which ESM cannot be held liable in any situation. I completely understand that in case embassy stops providing the embassy dates or is closed due to any unavoidable circumstances ESM cannot be held liable for that and therefore NO-REFUND cannot be demanded from the company. I understand that tuition fee will be refunded according to the refund policy of the concerned College/university.
