- 8. Where PAN provided to the deductor is invalid or does not belong to the customer, it will be ignored and the higher rate of TDS(20%) shall be applicable
- 9. Bariks are mandatorily required to issue Form 16A generated through TIN central system of Income-Tax Department:
 - a. The central system shall generate quarterly a consolidated PAN-based Form 16A to customers
- b. TN central system shall generate Form 16A with the name and address that would be available in Income-Tax Central Database
- c. TIN central system shall generate Form 16A only for those deductee whose valid PAN is available with the bank
- 10. If the understand and confirm that in terms of Section 206AB, the Bank is required to deduct higher rates of TDS effective from 1st July, 2021. If like have not filed income Tax Returns for two previous years immediately preceding the year in which tax is required to be deducted, time limit for filing of such income Tax Returns has expired and aggregate TDS in each of said two financial years is Rs.50,000/- or more. Accordingly, the tax shall be deducted at higher of the three rates viz. (a) twice the rate specified in the relevant provision of the Income tax Act. (b) twice the rate or rates in force (c) at the rate of 5%.
