do hereby solemn and declare that:-

All the documents provided with my application for a student visa for the United States of America are authentic and genuine. The concerned authorities have directly issued all the documents provided with my application. I shall be responsible for any bogus documents/information provided with my application. I also have access to sufficient funds from my parents/sponsor to bear all the expenses for my studies/living in the United States of America. I understand that I am responsible to provide any documentation required by the university and in case I fail to do so ESM cannot be held liable for any kind of refund or delay in the admission process.

I agree to pay a NON-REFUNDABLE registration fee of Rs. 40,000 (excluding GST) for the processing of my USA student visa application which includes the following services:- Registration with ESM, admission application processing, Visa application filling, Visa interview training and guidance. The above fee is only valid to process the admission in three universities/college and one time visa interview preparation and one time visa filling. It is also very clear to me that it completely depends on the university/college to provide the i20 after admission is done and ESM is not liable to provide all the three I20's to the student. I understand the entire fees paid to ESM INDIA for any purpose involved in the visa process are completely NON- REFUNDABLE and non-transferable. After successful visa approval, I also agreed to pay a consultation fee of Rs. 50,000/- (excluding GST) before collecting my visa copy.

I solemnly declare that I agree to pay any application fee, i20 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for the same. I understand that I have requested my Advisor to assist me for my admission in US University/College in which I am eligible for admission in desired program. I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.

I understand that I also have to pay a non refundable Sevis and embassy fee, which is USD \$350 and USD \$ 160 for Student visa to US Embassy via their channel partner AXIS Bank/credit card.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation. I completely understand that in case the embassy stops providing the embassy dates or is closed due to any unavoidable circumstances ESM cannot be held liable for that and therefore NO REFUND cannot be demanded from the company. I understand that the tuition fee will be refunded according to the refund policy of the concerned College/university. ESM has no influence to get visa appointments and refunds from the College/university.

Withdrawal clause:- In case I withdraw my application willingly before the visa/admission decision, I have agreed to pay the 50% of the consultation fee. I understand that any disputes arising under this will be subject to Chandigarh jurisdiction only.
