**Start Term:** Spring 2025

**Scholarship Offer:** A scholarship award letter is available on your Applicant Portal.

**Enrollment Deadline:** Submit your intent to enroll by December 15, 2024 to reserve your spot at SUNY Oswego. (Your tuition deposit will be waived.)

All international students must submit the following items (through your application portal or via email to [iss@oswego.edu](mailto:iss@oswego.edu)) in order to be issued a Form I-20 Certificate of Eligibility for Nonimmigrant Student Status:

- An original bank statement with a bank official's signature and stamp evidencing at least enough funds to cover one full year of study at SUNY Oswego (currently estimated at \$39,601 USD minus any applicable scholarships)
- A completed **SUNY International Student Financial Statement** (Parts 1, 2, B, and C) by you (the applicant) as well as whoever is financing your education (typically a parent). The form must be **"wet-signed" with a pen by the applicant and by the sponsor** (no electronic signature will be allowed)
- A scanned color copy of the biographical page of your passport

If you have any questions about the documents necessary to issue your Form I-20, please get in touch with SUNY Oswego's International Student and Scholar Services Office at [iss@oswego.edu](mailto:iss@oswego.edu). For your convenience, an advance deposit will not be required. Payment of the [I-901 SEVIS fee](#), which can be done only after you have received a Form I-20, will indicate your commitment to enroll at SUNY Oswego. You will be required to pay the full cost of attendance within five days of the start of classes for each new semester.

**Once you have completed your intent to enroll, you will receive further information on your next steps, including activation of your student account and meeting with your assigned advisor.**
