I also have access to sufficient funds from my parents/sponsor to bear all the expenses for my studies/living in the United States of America.

I agree to pay a NON-REFUNDABLE registration fee of Rs. 40,000 (excluding GST) for the one time processing of my USA student visa application which includes the following services:- Registration with ESM, admission application processing, Visa application filling, Visa interview training and guidance. The above fee is only valid to get you admission up to three universities/colleges and one time visa interview preparation and one time visa filling. I understand the entire fees paid to ESM INDIA for any purpose involved in the visa process are completely NON- REFUNDABLE and non-transferable. After successful visa approval, I also agree to pay a consultation fee of Rs. 50,000/- (excluding GST) before collecting my visa copy. I also understand that it is my duty to pay the fee after my visa is approved and inform the university regarding my travel plans. I solemnly declare that I agree to pay any application fee, i20 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for same. I understand that I have requested my Advisor to assist me for my admission in US University/College in which I am eligible for admission in desired program. I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.


I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD \$ 185 for Student visa to US Embassy via their channel partner AXIS Bank/credit card.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation. I completely understand that in case embassy stops providing the embassy dates or is closed due to any unavoidable circumstances ESM cannot be held liable for that and therefore NO REFUND cannot be demanded from the company. I understand that tuition fee will be refunded according to the refund policy of the concerned College/university. ESM has no influence to get visa appointments and refunds from the College/university.

Withdrawal clause:- In case I withdraw my application before visa/admission decision, I have agreed to pay the 50% of the consultation fee. I understand that any disputes arises under this will be subject to Chandigarh jurisdiction only.






