I solemnly declare that I agree to pay my application fee, 120 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for same. I understand that I have requested my Advisor to assist me for my admission in US University/College in which I am eligible for admission in desired program. I understand that if I have completed my Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.

I understand that I also have to pay non-refundable fees and company fee, which is USD 1350 and USD 185 for student visa to US Embassy via their official partner AUS Bank/credit card.

I understand that I have to face an interview conducted by my university and US embassy. Further, I understand that the authority of visa consular officers on my documents, statements, visa history and decision taken by the concerned embassy/consular officer for which ESM cannot be held liable in any situation. I completely understand that in case embassy stops providing the embassy dates or a travel date in any unavoidable circumstances ESM cannot be held liable for that and therefore NO REFUND cannot be demanded from the company. I understand that tuition fee will be refunded according to the refund policy of the concerned College/university. ESM has no influence to get visa appointments and refunds from the College/university.
