The above fee is only valid to get you admission up to three universities/colleges and one time visa interview preparation and one time visa filling. I understand the entire fees paid to ESM INDIA for any purpose involved in the visa process are completely NON- REFUNDABLE and non-transferable. After successful visa approval, I also agree to pay a consultation fee of Rs. 50,000/- (excluding GST) before collecting my visa copy. I also understand that it is my duty to pay the fee after my visa is approved and inform the university regarding my travel plans. I solemnly declare that I agree to pay any application fee, i20 fee, shipping fee, courier fee, tuition deposit or housing deposit directly to the university via my credit/debit card. I understand that the fees paid to ESM do not include these charges therefore I will be solely responsible for same. I understand that I have requested my Advisor to assist me for my admission in US University/College in which I am eligible for admission in desired program. I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.

I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD \$ 185 for Student visa to US Embassy via their channel partner AXIS Bank/credit card in which I will be able to reschedule his date only once applicable from 1 Jan 2025 after that I have to pay the embassy fee again as per US embassy guidelines.




