**RoarX India**, represented by Yogesh ("Employer"), having Proprietorship Firm with GST Number: 09AWXPY5625N1Z5, and registered address: ADDA RAM DAYAL, BHARTHANA ROAD ETAWAH, Uttar Pradesh, India.

### 1. POSITION:

The Employer appoints the Employee as a Customer Support Executive.

### 2. EMPLOYMENT TERMS:

- a. Start Date: The Employee's employment will commence on the Effective Date, starting from 2<sup>nd</sup> of August 2023.
