- I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD 185\$ for Student visa to US Embassy via their channel partner AXIS Bank/credit card in which I will be able to reschedule my date only once after that I have to pay the embassy fee again as per US embassy guidelines.
- I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation.
