I understand that if I have completed any Post Secondary Education, I will apply for a Credential Evaluation Report from one of the agencies approved from NACES and I will pay any additional expense required for the same. I also understand that my program eligibility depends on the report from the evaluation agency.
- I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD 185\$ for Student visa to US Embassy via their channel partner AXIS Bank/credit card in which I will be able to reschedule my date only once after that I have to pay the embassy fee again as per US embassy guidelines.
- I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassy/visa officer for which ESM cannot be held liable in any situation. I completely understand that in case the embassy stops providing the embassy dates or is closed due to any unavoidable circumstances ESM cannot be held liable for that and therefore **NO REFUND** cannot be demanded from the company.
- I also understand that it is my duty to pay the tuition fee after my visa is approved and inform the university regarding my travel plans.
