
### Affidavit cum contract

- I understand that I also have to pay non refundable Sevis and embassy fee, which is USD \$350 and USD 185\$ for Student visa to US Embassy via their channel partner AXIS Bank/credit card in which I will be able to reschedule my date only once after that I have to pay the embassy fee again as per US embassy guidelines.

I understand that I have to face an interview conducted by my university and US embassy, therefore I understand that the authority of visa issuance relies on my documents, interview, case history and decision taken by the concerned embassylvisa officer for which ESM cannot be held liable in any situation.
