On behalf of the Gannon community, please accept my congratulations on your acceptance into the Master of Science in Information Assurance and Cybersecurity program for the Spring 2024 semester at Gannon University. The semester begins on January 8, 2024. Our commitment to you includes an award of **\$1,500** toward your tuition fees, per semester when registered for full time enrollment. If accepted into the new program, the change will come into effect the following semester.
